

## **About Us**

The National Institute of Corrections (NIC) is the only federal agency with a legislative mandate (Public Law 93-41 5) to provide specialized services to corrections from a national perspective. NIC is recognized by other federal agencies for its unique role and quality services. Its leadership is evidenced by the numerous partnerships and interagency agreements targeted to provide correctional services and training.



NIC worked collaboratively with the Substance Abuse and Mental Health Services Administration and the US Department of Veterans Affairs to adapt the sequential intercept model for the justice-involved veteran population.

Each decision point in the criminal justice system represents an opportunity to divert and intervene at the lowest level possible and to minimize the collateral consequences for a veteran getting more deeply involved in the justice system.
